(Sept. 25, 2025) — The North Carolina Public Health Association (NCPHA), the largest Affiliate of the American Public Health Association, announced its 2025 scholarship and award winners during its awards ceremony on September 18 at the NCPHA Fall Educational Conference in Wilmington, NC. Award winners include individuals, health departments, and organizations that have made significant contributions to public health in North Carolina.

Award Winners

The Dr. Ann Wolfe Endowment was established to combat infant mortality and enhance child health. The 2025 Dr. Ann Wolfe Endowment Mini-Grants recipients include:

- AppHealthCare for its Childbirth Education Program.
- Montgomery County Health Department for its Safe Sleep Program.
- Warren County Health Department for its Child Safety Education Program.
- Catawba County Public Health for its Safe Sleep Initiative.
- The Distinguished Service award is given to a NCPHA member for their service to NCPHA. This year's recipient is **Suzanne Lea**, **PhD**, **MPH**, at East Carolina University.
- The Partners in Public Health Award recognizes other organizations and professions outside public health departments who have made significant contributions to public health in North Carolina over the past year. This year's recipient is El Centro based in Durham, NC.
- The Reynolds Achievement Award is bestowed upon the individual members of NCPHA
 who has made the greatest contribution to public health in North Carolina during the past
 year. This year's recipient is Andrea Freeman, MPHA, CLGFO, at Martin-Tyrrell-Washington
 District Health Department.
- The Rankin Legacy Award is given to a NCPHA member in recognition of the outstanding contributions to public health in North Carolina over the member's lifetime. This year's recipient is Latonya Jenkins at Martin-Tyrrell-Washington District Health Department.

The Dr. Sarah Taylor Morrow Health Department of the Year award is given to two health departments (small and large counties) for outstanding programs and efforts. The award recipients include:

- Carteret County Health Department for its overdose prevention efforts, resulting in a 69% reduction in overdose deaths in two years one of the largest reductions in North Carolina.
- Buncombe County Health and Human Services, Public Health for its Hurricane Helene response and recovery efforts, including helping to stand up and operate with state, federal, and community partners five shelters and twenty Community Care Stations to provide essential services to residents affected by the storm.
